I, the undersigned owner of the passenger vehicle, understand that if any of the documents of proof when submitted are not valid, proper or incorrect and for any reason I may not be eligible for the Special Commemorative Passenger Vehicle License Plate(s) etc., for which I have applied or received that I will be personally responsible for return of or repayment of or retribution to person, agency, Department or State that I applied to or received anything that I was not fully entitled to receive or fraudulent acceptance of anything to which I AM NOT ENTITLED and understand the penalties by law as stated in the Code of Alabama 1975, Section 13A-10-102.
