31 CHAIRMAN STRONG: ITEM NUMBER 3 IS DISCUSSION OF MEDICAL MARIJUANA 32 DISPENSARY LICENSING. JEFF?

- 34 MR. JEFF RICH: GOOD MORNING, MEMBERS OF THE COMMISSION. YOU MAY RECALL
- 35 THAT IN YOUR PREVIOUS MEETING, COMMISSIONER EDWARDS REQUESTED THAT THIS
- 36 BE PLACED ON THE AGENDA FOR DISCUSSION PURPOSES. I PROVIDED INFORMATION TO
- 37 YOU EARLIER IN THE WEEK TO HELP YOU WITH YOUR THOUGHT PROCESS AS YOU LOOK
- 38 AT YOUR ROLE WITH RESPECT TO THE RECENTLY-ENACTED LAW REGARDING MEDICAL
- 39 MARIJUANA LICENSING IN ALABAMA. YOU DO HAVE A ROLE, AS I EXPLAINED, BUT IT IS
- 40 A LIMITED ROLE TO SIMPLY ALLOW THE DOOR TO BE OPEN FOR MEDICAL MARIJUANA
- 41 SALES IN UNINCORPORATED MADISON COUNTY, AND I PROVIDED SOME INFORMATION
- 42 TO YOU AND HAD A DISCUSSION WITH COMMISSIONER EDWARDS. I THINK SHE HAS
- 43 DISCUSSION POINTS THAT SHE WANTS TO MAKE. SO, I'LL TURN IT OVER TO HER WITH
- 44 THAT.

- 46 COMMISSIONER EDWARDS: THANK YOU, MR. RICH FOR PUTTING IT ON THE AGENDA.
- 47 THANK YOU, MR. CHAIRMAN, FOR ALLOWING IT TO GO ON THE AGENDA. THIS WAS AN
- 48 ISSUE WE KNEW WAS COMING SINCE MAY OF 2021 WHEN GOVERNOR KAY IVEY SIGNED
- 49 THE LAW LEGALIZING MEDICAL CANNABIS. WE JUST KNEW IT WAS SOMETHING WE HAD
- 50 TO TAKE UP. WE JUST MOVED INTO THIS LATEST PHASE WHERE BUSINESSES ARE

APPLYING FOR DISPENSARY, CULTIVATING, PROCESSING AND TRANSPORTING OF THIS 1 2 LEGAL SUBSTANCE. SO, WE KNOW THAT THE PORTAL OPENED ON SEPTEMBER 1ST AND 3 WITHIN THE FIRST SIX DAYS, THE STATE RECEIVED 179 APPLICATIONS. 20 -- I'M SORRY, 4 19 OF THOSE IN THE FIRST SIX DAYS WERE FOR MADISON COUNTY. WE JUST HAVE A 5 DECISION TO MAKE. BEFORE IT IS CRUCIAL, I JUST WANTED TO GO AHEAD AND START 6 THE CONVERSATION. IT WAS INTRODUCED TO US AS A WHOLE BY SOMEONE WHO HAD 7 ECONOMIC INTEREST IN IT. I FEEL LIKE THE CONVERSATION IS BIGGER THAN THAT. THE 8 WHOLE POINT OF THIS WAS BECAUSE THERE WERE PEOPLE WHO NEEDED HELP 9 MEDICALLY. SO, I'VE ASKED, I'VE INVITED DR. PAM HUDSON TO COME AND SHARE WITH 10 US AS A PHYSICIAN, GETTING TO THE ROOT OF WHY THIS WAS EVEN SIGNED INTO LAW. THAT WAS BECAUSE THERE WERE PEOPLE, MEDICALLY, THAT NEEDED THIS 11 12 ASSISTANCE. SO, IF I COULD INVITE DR. HUDSON TO SHARE WITH US ON THE MEDICAL 13 SIDE OF WHAT THIS COULD MEAN FOR MADISON COUNTY.

DR. PAMELA HUDSON: THANK YOU, COMMISSIONER. I APPRECIATE THE OPPORTUNITY. IT'S A PRIVILEGE TO SERVE, BUT IT'S ALSO A HUGE TASK, SO THANK YOU VERY MUCH. ALSO, I APPRECIATE THE OPPORTUNITY TO BRUSH UP ON SOME THINGS THAT I'M NOT NECESSARILY AN EXPERT ON, BUT I TRIED TO PUT IN CONTEXT FOR YOU ALL. THINGS THAT YOU MIGHT BE ASKED IN CASUAL CONVERSATION AND A LITTLE BIT OF BACKGROUND. I SUSPECT MANY OF YOU KNOW MORE ABOUT THIS THAN I DO, BUT PERHAPS NOT AS MUCH ON THE MEDICAL SIDE. SO, I'LL BE BRIEF OR ELSE I KNOW I'LL GET THE HOOK.

26 DR. HUDSON: I WOULD PREFER TO CALL THIS MEDICAL CANNABIS BECAUSE THE 27 MARIJUANA NAME TAKES ON SOME SOCIAL CONTEXT THAT IS NOT REALLY IN OUR, ANY 28 OF OUR JURISDICTION AT THE MOMENT. AS YOU PROBABLY KNOW, IT IS A PLANT 29 DERIVATIVE. IT IS A NATURAL SUBSTANCE AND AS YOU MIGHT SUSPECT, THE BODY HAS 30 NATURALLY-OCCURRING RECEPTORS FOR THE CHEMICAL PRODUCTS THAT ARE IN 31 CANNABIS. THC IS THE FORM OF, DERIVATIVE OF THE PLANT THAT GIVES THE HIGH, 32 WHICH OBVIOUSLY HAS BEEN AN ISSUE FOR SUBSTANCE ABUSE. ALL THE WAY DOWN 33 TO CBD, WHICH HAS A THC CONTENT OF .3 PERCENT. SO, VERY TINY, WHICH IS WHY IT'S 34 LEGAL IN MANY PLACES AND IN FACT, IF YOU GO TO THE PET STORE, YOU CAN BUY SOME 35 FOR YOUR DOG. SOME OF THE TROUBLES WE HAVE AND SEE BOTH MEDICALLY AND I'M SURE, LEGALLY, IS THAT THE FEDERAL DRUG ENFORCEMENT AGENCY CLASSIFIES 36 37 CANNABIS AS A CLASS ONE OR SCHEDULE ONE DRUG, WHICH PUTS IT ON PAR WITH 38 OXYCONTIN AND THAT HAS THE ADDED DIFFICULTY THAT A LOT OF RESEARCH HAS NOT 39 BEEN DONE. IT'S BEEN YEARS. YOU ALL KNOW THAT CANNABIS HAS BEEN AROUND FOR 40 A LONG, LONG TIME, BUT THERE IS NOT AS MUCH RESEARCH AS YOU WOULD THINK FOR 41 A SUBSTANCE THAT HAS SUCH A LONG HISTORY. PART OF THE REASON FOR THAT IS 42 THAT, IN ORDER TO PERFORM RESEARCH WITH A SCHEDULE ONE DRUG, YOU HAVE TO 43 HAVE ALL KINDS OF DIFFERENT LICENSES. SO, IT CAN'T BE TAKEN UP JUST AS A ROUTINE 44 BY A COLLEGE CHEMIST, FOR EXAMPLE. WITHIN THAT, FEDERALLY, IT'S NOT A LEGAL 45 SUBSTANCE, EXCEPT FOR A COUPLE OF RARE FORMS OF EPILEPSY. EACH OF THE STATES THOUGH HAVE MADE SOME DECISIONS ABOUT IT, AND EACH OF THE STATES HAVE 46 47 VARIABLE DECISIONS THAT WERE MADE ON THE USE OF MEDICAL CANNABIS. AS THE LEGISLATURES WERE WRESTLING WITH THIS THROUGH THE '80S AND '90S, FINALLY THE 48 49 REQUEST WAS MADE THAT THE INSTITUTE OF MEDICINE COME OUT WITH A CONSENSUS OPINION TO GATHER THE INFORMATION AND TO REPORT. SO, THEY WERE ASKED IN THE 50

LATE 90'S TO ANSWER THREE QUESTIONS. CAN IT HELP MEDICAL CONDITIONS? IS IT 1 2 SAFE FOR MEDICAL USE? AND WHAT'S THE CONSENSUS ON THE SCIENCE? THE FIRST 3 TWO I'LL TOUCH ON. IN SHORT, THE ANSWER IS, YES; IT CAN HELP MEDICAL CONDITIONS. 4 SECONDLY, IS IT SAFE FOR MEDICAL USE? YES, BUT NOT IN THE SMOKED OR VAPED 5 FORM. SO, THOSE WERE PRETTY CLEAR CUT. THE LONGER VERSION OF THIS IS 100 6 PAGES. I CONFESS I HAVE NOT READ THE WHOLE THING. IF YOU WOULD LIKE ME TO 7 COME BACK AND REPORT IN THE FUTURE, I WILL BE HAPPY TO DO THAT. ACTUALLY, I 8 PROBABLY SHOULD NOT OFFER THAT.

DR. HUDSON: CURRENTLY, THERE ARE 37 STATES THAT ALLOW MEDICAL CANNABIS 12 13 AND ALABAMA, NOW, ONE OF THOSE. THERE ARE TWO TYPES OF LEGALIZATION FORMS. 14 ONE IS A LOW DOSE OR RESTRICTED USE, WHICH IS THC CONCENTRATIONS OF 3 PERCENT 15 OR LESS. THOSE STATES AROUND US THAT DO THIS LOW-DOSE RESTRICTED FORM ARE GEORGIA AND TENNESSEE. THE OTHER IS A MORE COMPREHENSIVE. OR WHAT'S 16 17 SOMETIMES REFERRED TO AS INTEGRATED LEGALIZATION, AND ALABAMA, MISSISSIPPI 18 AND FLORIDA HAVE THOSE. THAT INCLUDES THE PRODUCTION, THE GROWING AND ALL 19 THE OTHER PIECES OF THAT AND THE MEDICAL PIECES, OBVIOUSLY, WITH MORE 20 AVAILABILITY ARE IN THOSE COMPREHENSIVE STATES. AGAIN, I'LL REITERATE THAT 21 CURRENTLY, FEDERALLY, THE FDA HAS ONLY RECOGNIZED TWO TREATMENTS -- I'M 22 SORRY, TWO QUALIFYING CONDITIONS AND THEY'RE BOTH RARE FORMS OF EPILEPSY. 23 IN ALABAMA, AS YOU KNOW, THERE WERE A SIGNIFICANT SET OF REGULATIONS THAT 24 WERE ADOPTED AND ARE DUE TO GO INTO EFFECT IN 2023. IT'S IMPORTANT TO NOTE 25 THAT THERE CAN BE NO PRESCRIBING OF MEDICAL CANNABIS UNTIL THE LICENSES ARE 26 GRANTED. IT'S A POINT WHERE THE FLAG DROPS AND PRESCRIBERS CAN ASK FOR THEIR SPECIAL LICENSE. THERE ARE DIFFERENT PIECES OF THIS. FIRST PRODUCTION, THEN 27 28 DISTRIBUTION, ET CETERA AND DISPENSING. I'M NOT GOING TO TALK ABOUT THAT. I'M 29 GOING TO TRY TO GIVE YOU SOME SENSE OF WHY IT MAY BE USEFUL. THERE ARE 30 DIFFERENT FORMULATIONS OF MEDICAL CANNABIS. IT CAN BE IN PILL FORM. IT CAN 31 BE IN LIQUID FORM. IT CAN BE SMOKED AND VAPED. IT CAN BE TOPICAL, RUBBED ON 32 THE SKIN AND THERE ARE DIFFERENT RISKS FOR THE HIGH SENSATION, BASED ON THE 33 CONCENTRATION AND THE METHOD OF DELIVERY. BUT AGAIN, IN THE USE OF MEDICAL 34 CANNABIS, THAT HIGH IS NOT THE END GOAL AND IN FACT, IT'S QUITE UNPLEASANT FOR 35 MANY FOLKS WHO DON'T HAVE A PERSONAL HISTORY OF HAVING USED MARIJUANA IN THE PAST. IT'S A VERY UNPLEASANT SENSATION. SO, IN ALABAMA, PRESCRIBERS HAVE 36 TO BE PHYSICIANS, M.D. OR D.O. THEY HAVE TO HAVE THREE OR MORE YEARS OF 37 38 EXPERIENCE IN CLINICAL PRACTICE AFTER THEIR RESIDENCY TRAINING PROGRAM. THIS 39 IS NOT LIKELY TO BE SOMETHING THAT A YOUNG MEDICAL STUDENT OR RESIDENT WOULD SAY "THIS IS HOW I'M GOING TO MANAGE MY CAREER." YOU HAVE TO HAVE 40 41 THAT EXPERIENCE. THEY ALSO HAVE TO HAVE AN ACTIVE ALABAMA LICENSE, 42 UNRESTRICTED. HAVE TO HAVE AN ALABAMA CONTROLLED SUBSTANCE LICENSE AND FEDERAL DEA NUMBER. SO, ALL THOSE THINGS COST MONEY AND ARE HEAVILY 43 44 THIS IS NOT SOMETHING SOMEBODY CAN ACHIEVE CASUALLY. IN 45 ADDITION, THE PRESCRIBER HAS TO APPLY FOR A SPECIAL LICENSE THAT COSTS \$300. THAT IS EQUAL TO WHAT DOCTORS PAY FOR THEIR ALABAMA STATE MEDICAL LICENSE. 46 47 SO, SUBSTANTIAL FEE RELATED TO THAT AND THAT FEE REOCCURS WHEN THEY REAPPLY FOR CONTINUATION OF THEIR LICENSE TO PRESCRIBE MEDICAL CANNABIS. IN 48 ADDITION, THEY HAVE TO TAKE FOUR HOURS OF TRAINING, SPECIFIC TO MEDICAL 49 CANNABIS PRESCRIBING AND THEY HAVE TO PARTICIPATE, THEMSELVES, IN A REGISTRY 50

AND THEY HAVE TO COMMIT TO REGISTERING EACH OF THEIR PATIENTS. THEY ALSO 1 2 ARE COMMITTING TO THE RULE THAT REQUIRES THAT BEFORE THEY PRESCRIBE 3 MEDICAL CANNABIS, THEY HAVE TO RESEARCH WHAT'S CALLED THE PDMP, A REGISTRY 4 OF NARCOTIC PRESCRIPTIONS, SO THEY CAN -- THEY'LL BE LOOKING TO SEE, HAS 5 ANYBODY ELSE PRESCRIBED MEDICAL CANNABIS FOR THIS PATIENT? ARE THEY TAKING 6 OTHER SUBSTANCES, CONTROLLED SUBSTANCES? THEY ALSO HAVE TO AND THIS IS 7 WHERE I'M A PRIMARY CARE PHYSICIAN BY TRAINING. THIS IS REALLY CRITICAL. THIS 8 IS NOT A ONE AND DONE. PATIENTS WILL NOT BE ABLE TO COME TO A PHYSICIAN AND 9 SAY, "I'VE GOT A OUALIFYING CONDITION, WILL YOU PLEASE GIVE ME A PRESCRIPTION?" 10 THEY HAVE TO HAVE AN ONGOING RELATIONSHIP WITH THAT PHYSICIAN. THESE ARE 11 GOING TO BE EITHER ONCOLOGISTS OR NEUROLOGISTS WHO ARE ALREADY SEEING 12 THEM FOR CONDITIONS OR PRIMARY CARE PHYSICIANS WHO ARE ASSISTING PATIENTS 13 IN THE LAST STAGES OF A TERMINAL ILLNESS AND THE PHYSICIAN IS REQUIRED TO 14 HAVE ONGOING FOLLOW-UP. YOU CAN'T REFILL THESE PRESCRIPTIONS OVER THE PHONE AND THAT SORT OF THING. IN ADDITION, THE PHYSICIAN IS REQUIRED TO DO A 15 RISK-BENEFIT CONSULTATION WITH THE PATIENT. THE PATIENTS HAVE TO SIGN THAT 16 17 THEY HAVE INFORMED CONSENT TO UTILIZE THE PRESCRIPTION. INTERESTINGLY, 18 THERE ARE ALSO DOSE LIMITATIONS. I HAVE NOT SEEN THAT IN OTHER LEGISLATION. 19 SO, YOU CANNOT -- THE PHYSICIAN CANNOT JUST KEEP ADDING MORE, EITHER A HIGHER 20 CONCENTRATION OR MORE PILLS. THERE ARE CUT-OFFS, SO THE STATE WILL BE INFORMED IF THERE ARE GOING TO BE ANY EXCEPTIONS. SO, I WOULD EXPECT AND 21 22 ACTUALLY HAVE TOUCHED BASE WITH A COUPLE OF MY COLLEAGUES. ONCOLOGISTS 23 WOULD PROBABLY BE THE FIRST GROUP OF PHYSICIANS WHO WOULD BE THINKING ABOUT, CONTEMPLATING AND PROBABLY GETTING PRESCRIBING LICENSES SO THEY 24 25 CAN HELP THEIR PATIENTS BECAUSE ONE OF THE QUALIFYING CONDITIONS IS 26 PROBABLY ONE THAT EVERYBODY IN THIS ROOM HAS HAD, THE UNFORTUNATE ENCOUNTER WITH NAUSEA, THE SEVERE NAUSEA AND VOMITING WITH CHEMOTHERAPY 27 28 FOR MALIGNANCY DIAGNOSES. QUALIFYING CONDITIONS, I WOULD SAY TO YOU, AS FAR 29 AS I KNOW, THERE'S NO CONDITION WHERE MEDICAL CANNABIS IS THE FIRST LINE 30 MEDICATION. SO. MEDICAL CANNABIS WOULD BE COMING IN AFTER THE FAILURE OF 31 OTHER APPROVED TREATMENT REGIMENTS OR MIGHT BE USED AS AN ADJUNCT TO TRY 32 TO GET THE SYMPTOMS RESOLVED TO THE VERY BEST FOR THE PATIENT'S BENEFIT. 33 THERE ARE 16 CONDITIONS IN ALABAMA THAT ARE INCLUDED IN THE LEGISLATION AND 34 DEPENDING HOW YOU LUMP THEM TOGETHER, JUST GENERALLY, THE SEVERE NAUSEA 35 AND VOMITING, UNRESPONSIVE TO NORMAL TREATMENTS, RELATED TO CANCER, CHEMOTHERAPY, INTRACTABLE NAUSEA THAT SOMETIMES OCCURS IN ILLNESSES WITH 36 37 PATIENTS AND THAT HAS BEEN ONGOING AND UNABLE TO BE CONTROLLED WITH OTHER 38 TREATMENT OF WASTING, WHICH MEANS THAT THEY CAN'T, THEIR 39 APPETITE IS SO LOW THAT THEY CAN'T PUT BODY WEIGHT ON AND STAY AT, NOT JUST A HEALTHY WEIGHT, BUT A SURVIVABLE WEIGHT, AND THAT'S VERY COMMON DISEASES 40 41 LIKE HIV, AIDS AND ALSO IN CANCER. CHRONIC PAIN IS ALSO LISTED FROM THE STATE 42 OF ALABAMA AND THAT IS, AGAIN, CHRONIC PAIN IS, IT'S DEFINED AS A MEDICAL 43 CONDITION. IT'S NOT "I BROKE MY LEG AND THE PAIN HAS BEEN THERE FOR TWO DAYS." 44 THAT WOULD NOT FIT THE BILL. WE'RE TALKING ABOUT PEOPLE WHO HAVE ONGOING, 45 LONG-TERM TREATMENT FOR CHRONIC PAIN CONDITIONS THAT HAVE BEEN UNRESPONSIVE TO OTHER METHODS. THE NEUROLOGIC DISEASES IS ANOTHER CLUSTER 46 47 OF DISEASES WHERE YOU CAN EXPECT TO SEE AND THUS, THE NEUROLOGIST, I THINK, PROBABLY WOULD BE SECOND IN LINE. THE SPASTICITY THAT OCCURS WITH MULTIPLE 48 49 SCLEROSIS OR MS. AS YOU KNOW, THE HUNTSVILLE, MADISON COUNTY AREA IS A HOT BED FOR ALS, PARTLY BECAUSE OF OUR MILITARY CONNECTION AND IT TENDS TO 50

CLUSTER IN LARGER CITIES, OBVIOUSLY. SO, THAT IS ANOTHER PIECE IN PARKINSON'S 1 2 DISEASE. THAT WAS A NEW ONE TO ME. MEDICAL CANNABIS DOES HAVE A PLACE IN 3 ALL THAT AND IN TALKING WITH MY COLLEAGUES, I THINK THAT WE WILL SEE FOLKS 4 MOVE QUICKLY TO BE ABLE TO HELP PATIENTS UNDER THESE, AGAIN, VERY STRINGENT 5 PRESCRIBING REQUIREMENTS. THERE ARE ALSO PATIENT RESPONSIBILITIES. 6 PATIENT HAS TO HAVE THAT PRESCRIPTION. THEY CAN'T JUST APPEAR AT A DISPENSARY 7 AND TRY TO ENUMERATE THEIR CONDITIONS AND HOPE TO GET A MEDICATION. THEY 8 HAVE TO AGREE AND PARTICIPATE IN A REGISTRY AND THEY ALSO PAY A FEE. THEY 9 HAVE TO PRESENT THE PRESCRIPTION OR A LETTER FROM THE PHYSICIAN THAT OPENS 10 THE DOOR FOR THEM TO GET THAT, AND THEY MUST PURCHASE AT A LICENSED 11 DISPENSARY. SO, YOU CAN'T TAKE THAT. THEY ACTUALLY GET AN ID CARD. THEY 12 CAN'T TAKE THAT CARD TO YOUR LOCAL FARMING COMMUNITY AND SEE WHAT'S AVAILABLE. SO, AS YOU CAN SEE, THERE ARE SIGNIFICANT ILLNESS CONSTELLATIONS 13 14 THAT AND SYMPTOMOLOGY THAT MEDICAL CANNABIS IS AN ADJUNCT IN TREATMENT. 15 BUT THERE ARE, IN READING THE LEGISLATION AND CAUTIONS THAT THE ALABAMA BOARD OF MEDICAL EXAMINERS HAVE PUT IN PLACE. THEY'RE PRETTY STRICT AND 16 17 EVEN MORE STRICT THAN SOME NARCOTICS. I BELIEVE THAT'S THE CONCLUSION OF MY 18 REMARKS, BUT IN THE SPIRIT OF THE PASTOR'S COMMENT, I WOULDN'T BE DOING MY 19 DUTY IF I DIDN'T REMIND YOU THAT THE BIVALENT COVID VACCINE IS AVAILABLE IN 20 OUR COMMUNITY AND I HOPE EVERYBODY WILL AVAIL THEMSELVES, SO WE CAN HAVE 21 SOME PROTECTION AGAINST THIS WILDFIRE OF OMICRON THAT'S GOING THROUGH. SO, 22 APOLOGIZE FOR THAT.

WANTED TO DIG IN DEEP AND TRY TO FIGURE OUT, BUT I SUSPECT THAT THE PRODUCERS
 AND DISPENSERS HAVE ALREADY DONE THAT WORK. SO, YOU MIGHT ASK WHAT THEY
 THINK THEIR TARGET MARKET IS.

 COMMISSIONER RIDDICK: I HAVE A COMMENT THAT I WOULD LIKE TO MAKE. AS WE CONSIDER THIS, I WANT THE PUBLIC TO KNOW THAT THESE LICENSES ARE NOT GOING TO BE GIVEN OUT LIKE CANDY. THERE ARE NOT GOING TO BE LIKE CBD STORES ON EVERY CORNER. THERE ARE ONLY FOUR LICENSEES STATEWIDE FOR DISPENSARIES, TO MY KNOWLEDGE, AND THEY CAN EACH HAVE UP TO THREE SITES. ON THE INTEGRATED FACILITIES, I THINK THERE ARE ONLY FIVE LICENSEES STATEWIDE AND EACH OF THOSE CAN HAVE FIVE SITES. SO, THERE ARE ONLY A MAXIMUM OF 37 COUNTIES THAT COULD EVEN HAVE THIS. I DON'T THINK IT'LL BE SOMETHING THAT WE'LL SEE THESE THINGS ON EVERY STREET CORNER, BUT I DO HAVE A QUESTION AND JEFF, MAYBE THIS IS A QUESTION FOR YOU. JURISDICTIONALLY, LET'S SAY THE CITY OF HUNTSVILLE DID THIS AND APPROVED IT, WHAT WOULD THAT MEAN TO MADISON COUNTY?

MR. RICH: THEIR APPROVAL WOULD BE APPROVAL WITHIN THE CITY LIMITS, SUBJECT TO THEIR ZONING REQUIREMENTS AND OTHER LAWS THAT THEY HAVE THAT MIGHT GOVERN OPERATION OF ANY KIND OF RETAIL ESTABLISHMENT BUT WOULD MEAN NOTHING AS TO THE UNINCORPORATED AREAS OF MADISON COUNTY. CITIZENS LIVING IN THE STATE OF ALABAMA COULD COME TO THAT LOCATION AND BUY, WHETHER THEY'RE A CITIZEN OF CULLMAN COUNTY OR JEFFERSON COUNTY OR WHEREVER, AS LONG AS THEY'RE CITIZENS OF THE STATE.

COMMISSIONER RIDDICK: PRESUMING THERE ARE ONLY A FEW LICENSEES IN THE CITY OF HUNTSVILLE, WE PROBABLY WOULDN'T GET ONE IN MADISON COUNTY ANYWAY. WOULD THAT STAND TO REASON?

MR. RICH: I DO NOT KNOW. THE LICENSING SCHEME AND I DID NOT BRING IT WITH ME, BUT THE LAW ITSELF IS ABOUT THAT THICK. THE REGULATIONS THAT HAVE BEEN ADOPTED BY THE DEPARTMENT OF AGRICULTURE AND EXAMINER'S BOARD ARE ABOUT THAT THICK. SO, THERE ARE A MYRIAD OF FACTORS THAT GO INTO CONSIDERING A LICENSE APPLICATION AND WHO GETS IT AND LOCATION AND I'M SURE DEMOGRAPHICS AND NUMBER OF POTENTIAL PURCHASERS AND USERS. ALL OF THAT. SO, I WOULD BE HESITANT TO SAY THAT IF HUNTSVILLE GETS ONE, THAT WOULD BE THE ONLY ONE THAT WOULD BE APPROVED IN ALL OF MADISON COUNTY. MIGHT VERY WELL BE, BUT I WOULD BE HESITANT TO SAY SO.

COMMISSIONER RIDDICK: IF I WAS A LICENSEE AND WAS TRYING TO SPREAD OUT AND HAD ONLY FIVE OR FOUR POSSIBLE LOCATIONS, I DON'T THINK I WOULD WANT TO PUT TWO OF THEM IN THE SAME COUNTY.

43 MR. RICH: I DO NOT KNOW. I AM SURE THEY ARE LOOKING AT THINGS LIKE WHERE ARE
44 REGIONAL MEDICAL CENTERS BECAUSE THOSE ARE GOING TO BE HOT BEDS FOR
45 PRESCRIPTIONS. SO, YOU LOOK AT HUNTSVILLE HOSPITAL AND UAB'S PRESENCE HERE.
46 NO OFFENSE TO CRESTWOOD.

50 MR. RICH: THEY HAVE A REGIONAL MEDICAL CENTER. I DO NOT KNOW THE ANSWER TO

YOU KNOW, IN ALL MY YEARS, THOUGH, THIS IS 11 THE FIRST -- I THINK THIS IS THE FIRST COUNTY COMMISSION MEETING I'VE EVER BEEN 12 TO AND IT'S BECAUSE I REALIZE THE IMPORTANCE OF STAYING IN MY LANE AND 13 EVERYBODY, OUR SYSTEM OF GOVERNANCE WORKS WHEN EVERYBODY STAYS IN THEIR 14 LANE. AS YOU KNOW, I SPENT A CAREER IN LAW 19 ENFORCEMENT AND I HAD A LOT OF THE SAME CONCERNS THAT LAW ENFORCEMENT 20 21 HAS OVER IT. I WAS QUITE FAMILIAR WITH PEOPLE WHO ABUSE IT AND QUITE FRANKLY, 22 THE CRIME THAT IS CAUSED BY PEOPLE WHO ABUSE IT, IT IS THERE NOW. THE WEED 23 MAN IS OUT THERE. THEY HAVE TO FIGHT IT ALL THE TIME. IN 25 OCTOBER OF 2013, I WAS JUST AS OPPOSED TO ANY KIND OF MARIJUANA LEGALIZATION 26 AS ANYBODY IN THIS COUNTY. WHEN THEY INTRODUCED THOSE MEDICAL BILLS, I JUST, 27 I'D HELP KILL THEM BECAUSE I THOUGHT IT WAS A BACK DOORWAY TO SMOKE POT AND 28 GET HIGH. AS FAR AS I KNEW, IT WAS A SCHEDULE ONE NARCOTIC AND I WAS UNAWARE 29 OF ANY MEDICAL VALUE TO IT UNTIL I GOT AN E-MAIL FROM A LADY, SHERRY GIBBS, 30 WHO LIVES IN YOUR DISTRICT, COMMISSIONER VANDIVER. I GOT AN E-MAIL FROM HER 31 IN THE MIDDLE OF THE NIGHT -- PLEASE LEGALIZE MARIJUANA AND I ALMOST DELETED 32 IT, BUT SOMETHING MADE ME READ IT BECAUSE THE NEXT LINE WAS, "WE DON'T EVEN 33 DRINK, WE'RE CHRISTIANS, BUT MY GRANDDAUGHTER IS SUFFERING." THERE IS A 34 PICTURE OF HER AND AS I READ THROUGH THAT, AND SHE WAS TALKING ABOUT THE 35 CBD OIL AND CANNABIS, I THOUGHT IT WAS SNAKE OIL. AS MANY OF YOU KNOW, I WAS AN INVESTIGATOR BEFORE I EVER GOT INTO POLITICS. ONE OF MY BIGGEST PROBLEMS 36 37 AS A POLITICIAN HAS BEEN THAT THE INVESTIGATOR AND POLITICIAN INSIDE MY HEAD 38 FIGHT ALL THE TIME. THE INVESTIGATOR USUALLY WINS, BUT IT IS HARD. I KNOW EVERYBODY -- JOSEPH, I'M GOING TO START 11 WITH JUST A COUPLE HIGHLIGHTS AND THEN THERE MAY BE SOME MORE OUESTIONS. 12 CURRENTLY, THIS BUDGET THAT IS BEING RECOMMENDED TO THE COMMISSION IS A TOTAL BUDGET OF \$240,512,430. OF THAT, THE GENERAL FUND IS \$87,618,025, AND OF 13 14 COURSE, THE TOTAL BUDGET ENCOMPASSES THE ENTERPRISE ACCOUNTS FOR THE 15 BENEFIT OF PEOPLE WHO MAY BE WATCHING THIS. YOU LOOK AT OUR RESERVE STATUS -- IT IS VERY STRONG. THIS IS ANOTHER BALANCED BUDGET THAT INCLUDES AN 8.6 16 17 COLA FOR ALL FULL-TIME EMPLOYEES. ALL COMPENSATION CHANGES ARE PENDING 18 REVIEW OF THE COMPENSATION ANALYST. YOU START LOOKING AT SOME OF THE 19 THINGS THAT ARE IN THIS BUDGET, FROM THE WATER DEPARTMENT AND ON DOWN, A 20 LOT OF THINGS TO MAKE IT BETTER. ONE OF THE THINGS THAT WE HAVE TO DO IS TO 21 ADOPT THIS BUDGET, AND ADOPTION OF THIS BUDGET REQUIRES THAT THE EMPLOYEES' 22 HANDBOOK BE AMENDED TO REMOVE APPENDIX 6, PROCEDURE 4, PARAGRAPH 2 23 THROUGH 4 AND PROCEDURE 4. WHAT WE HAVE IS A PROCESS THERE THAT LIMITS 24 INCREASE -- IS LIMITED TO 7.5 PERCENT, AND OF COURSE, THIS RECOMMENDATION OF A 25 COST-OF-LIVING RAISE IS 8.6 PERCENT. OTHER THINGS THAT ARE IN THIS. YOU LOOK AT 26 HEALTH INSURANCE CHANGES -- IT INCLUDES 6.4 PERCENT INCREASE. OF THAT, 80 PERCENT IS PAID BY THE TAXPAYERS OF MADISON COUNTY AND 20 PERCENT IS PAID BY 27 28 THE EMPLOYEE. THE WATER DEPARTMENT HAS ABOUT \$5.2 MILLION IN CAPITAL 29 PROJECTS THAT ARE INCLUDED IN THIS BUDGET. SOME OF THOSE, WE'LL JUST TOUCH SO THAT EVERYBODY KNOWS WHAT THAT IS GOING TOWARD. IT INCLUDES \$154.000 FOR 30 31 SERVICE TRUCKS, \$247,000 FOR DUMP TRUCKS, \$287,000 FOR BACKHOES, \$72,000 FOR 32 TRAILERS, \$221,000 FOR SERVICE TRUCKS OR VEHICLES. IT ALSO INCLUDES MINI X, 33 \$155,000, \$83,000 FOR SOME GPS UNITS. YOU START LOOKING AT WASTE CONTROL IN THIS 34 BUDGET RIGHT HERE FOR WASTE CONTROL, IT INCLUDES FIVE OF THE M2 112 FREIGHT LINERS THAT COST \$1.85 MILLION. IN INCLUDES \$82,000 TO REPLACE SOME OF THESE 35 OLDER TRUCKS, EQUIPMENT TO CLEAN UP WHEN WE HAVE SITUATIONS THAT OCCUR IN 36 PROVIDING THAT SERVICE, IT INCLUDES THAT. AGAIN, THAT WILL MAKE THAT 37 38 DEPARTMENT A LOT BETTER. IF YOU LOOK DOWN TO THE PROBATE JUDGE'S OFFICE, 39 THERE ARE A LOT OF MOVING PARTS THERE. I KNOW IT HELPS CLEAN UP THE CLERK'S POSITIONS. WE HAVE TWO CHIEFS WHO WILL BE ADDED THERE, DIVIDING THE 40 41 DEPARTMENT WHERE THEY HANDLE THE WORK THAT IS HAPPENING THERE. THE 42 BUILDING INSPECTION DEPARTMENT, IT INCLUDES FOR THEM TEN TRUCKS, SO THAT THEIR INSPECTORS CAN DO THE JOB THAT IS THERE. WE'VE GOT OUTDATED TRUCKS AS 43 44 PART OF THAT. THE FARMER'S MARKET -- WE'RE GOING TO REDO THE PAVING AND 45 STRIPING OF THE PARKING LOT THERE. IF YOU LOOK AT HUMAN RESOURCES, THEY'RE GOING TO DIGITIZE SOME OF THE EMPLOYEE PERSONNEL FILES, RATHER THAN ALL THE 46 47 PAPERWORK THAT GOES THERE. THEN, OF COURSE, IF YOU LOOK AT THE SHERIFF'S DEPARTMENT, WHICH IS THE LARGEST BUDGET IN MADISON COUNTY. THE SHERIFF'S 48 49 DEPARTMENT HAS SEVERAL THINGS THAT ARE PART OF THEIR BUDGET TO INCLUDE FOUR ADDITIONAL DEPUTIES FOR MADISON COUNTY. IF YOU LOOK AT WHERE WE WERE 50

LESS THAN TEN YEARS AGO, THE SHERIFF'S DEPARTMENT HAD A TOTAL OF 111 -- IN 1 2 NOVEMBER 2012, HAD 111 FULL-TIME AND PART-TIME EMPLOYEES. THIS, RIGHT HERE, 3 WILL TAKE THE SHERIFF'S DEPARTMENT TO 178 FULL-TIME, A-POST CERTIFIED DEPUTIES. 4 THAT ARE THERE IS A BIG DIFFERENCE COMPARED TO WHERE IT WAS TEN YEARS AGO. 5 THIS COMMISSION HAS ADDED 67 NEW DEPUTIES TO PATROL MADISON COUNTY IN THE 6 LAST TEN YEARS AND I COMMEND EACH OF YOU FOR THAT. YOU LOOK THROUGH SOME 7 OF THE OTHER THINGS THAT ARE INCLUDED IN THIS BUDGET, MUCH OF IT IS JUST 8 OPERATIONS COST -- THE JAIL, BUT IF YOU LOOK AT THE TOTAL BUDGET, 48 PERCENT OF 9 EVERY DOLLAR THAT COMES TO THE GENERAL FUND GOES TO MADISON COUNTY 10 SHERIFF'S DEPARTMENT. THAT IS SOMETHING THAT I TAKE PRIDE IN AND KNOW THIS 11 COMMISSION DOES. YOU START LOOKING AT AN AVERAGE OF ALMOST 1,000 INMATES A 12 DAY. THAT IS A HUGE COST TO THE TAXPAYERS, BUT IT IS A WORTHY COST. YOU START LOOKING, 25 PERCENT OF THEIR BUDGET GOES TO THE JAIL. SO, OF THE 48 PERCENT, 25 13 14 PERCENT OF THAT GOES TO THE JAIL AND 23 PERCENT OF IT GOES TO THE SHERIFF AND 15 THEIR OPERATION OF THEIR PATROL DIVISION. I'M PROBABLY BETTER OFF TO OPEN THIS UP FOR DISCUSSION, BUT AGAIN, THE BUDGET IS BALANCED. I THANK EVERYONE WHO 16 17 HAS PARTICIPATED. I THANK THE COMMISSIONERS WHO HAVE CALLED WITH 18 QUESTIONS EITHER TO ME OR JOSEPH, CAROL OR ANYBODY IN THE FINANCE DIVISION, 19 BUT AGAIN, OPEN FOR OUESTIONS AND TELL YOU WHAT -- SO THAT WE CAN DISCUSS IT, 20 IF WE CAN HAVE A MOTION AND SECOND FOR DISCUSSION PURPOSES. I THINK 46 47 ABOUT THE SHERIFF'S DEPARTMENT. IT INCLUDES A \$300,000 PURCHASE OF AN ARMORED BEARCAT. THAT IS SOMETHING YOU DON'T NEED UNTIL YOU NEED IT. YOU 48
- 49 CAN'T GET IT UNTIL THE LAST SECONDS. IT'S PROVEN IT'LL SAVE LIVES. I THINK THAT'S
- A VERY GOOD INVESTMENT. THE FOUR NEW DEPUTIES, I KNOW THE COMMISSION HAS 50

COMMISSIONER, I THINK I CUT YOU OFF.

HAD, EVERYBODY HAS COMMENTED ON THAT. WE MADE A GOOD STRIDE IN ADDING
 ADDITIONAL DEPUTIES. THESE ADDITIONAL DEPUTIES WILL HAVE HELP IN MANY WAYS

10 CHAIRMAN STRONG: ABSOLUTELY. WHAT WE DO, WE GO AND TAKE. THERE IS A THREE-11 MIL TAX THAT IS CHARGED IN UNINCORPORATED MADISON COUNTY. THE PEOPLE OF 12 MADISON COUNTY VOTED THIS IN, AND THE COLLECTION OF THE THREE-MIL TAX, THEY GO TO THE TAX ASSESSOR'S OFFICE AND GO TO EACH -- TO THE 911 CENTER AND THEY 13 14 FIND OUT HOW MUCH IS COLLECTED WITHIN EACH DEPARTMENT. WE HAVE A FLOOR. 15 IT DOES NOT MATTER HOW SMALL THE DEPARTMENT MAY BE OR HOW FEW CALLS THEY RUN THERE. WAS A FLOOR OF X. THERE WAS AN INCREASE IN THAT. THERE IS ALSO THAT 16 17 NO DEPARTMENT WILL GET LESS THAN 60 PERCENT OF WHAT IS COLLECTED FROM THEIR 18 DISTRICTS. IT IS A SELF-IMPOSED TAX. THAT, RIGHT THERE WE'RE SEEING AS THE 19 GROWTH CONTINUES THAT OTHER, MANY DEPARTMENTS ARE NOW GETTING INCREASES 20 AND THAT WILL CONTINUE BASED ON THE COLLECTION. THERE'S ALSO AN ALCOHOL 21 TAX THAT WAS PASSED BY THE LEGISLATURE AND WHAT RETURNS, THERE'S A 22 PERCENTAGE OF THAT THAT RETURNS TO THE VOLUNTEER FIRE DEPARTMENTS. FOR 23 INSTANCE, AT ONE POINT, I THINK THERE WAS ONLY ALCOHOL BY THE DRINK. I THINK 24 IN MERIDIANVILLE. NOW, I THINK THERE IS ALCOHOL BY THE DRINK IN SEVERAL OF THE 25 DISTRICTS AND WHATEVER IS COLLECTED IN A TAX, IT'S NOMINAL, BUT IT GOES BACK 26 TO THE AFFECTED AREA OF WHERE IT WAS COLLECTED. THERE HAS BEEN AN INCREASE 27 -- AS A MATTER OF FACT, EVERY ONE OF THEM GOT AN INCREASE THIS YEAR, BUT THE 28 GROWTH IS, COMMISSIONER, HEADED YOUR WAY. EVERY DISTRICT IS GROWING, BUT 29 EVERYBODY KNOWS THE SUBDIVISIONS WE APPROVED THAT THERE IS A LOT OF

50 WHEN WE TAKE IT TO THE HUMANE SOCIETY. OF COURSE, THAT INCLUDES A RABIES

SHOT, A FLEA PILL AND MAYBE SOME OTHER THINGS THERE. IT'S PRETTY COSTLY. I

JUST BELIEVE THAT CURRENTLY, WE'VE GOT ENOUGH ANIMAL CONTROL OFFICERS TO

HANDLE IT. I AM NOT SAYING THAT IT WON'T HAVE TO BE RELOOKED AT, BUT AGAIN,

IT'S A PRETTY COSTLY SITUATION AND I THINK WE OUGHT TO GO BASED ON COST AND

DON'T THINK WE NEED ADDITIONAL PATROLS TO PICK UP ANIMALS. THERE ARE A LOT

OF DIFFERENT THOUGHTS ON THAT. I KNOW THAT IS ONE DEAR TO YOUR HEART,

COMMISSIONER.

COMMISSIONER EDWARDS: IT IS AND I --

CHAIRMAN STRONG: IT IS A HARD DECISION BUT BASED ON \$45,000 IN COLLECTIONS AND A \$455,000 BUDGET, I FELT THAT IF WE EXPANDED THAT, IT COULD POTENTIALLY TAKE US BACK IN THE DIRECTION OF WHERE WE WERE TEN YEARS AGO, WHERE WE WERE STARING AT A TOUGH FINANCIAL SITUATION. IT MAY NEED TO BE RELOOKED AT A LATER DATE AND BEING SURE THAT WE HAVE APPROPRIATE VEHICLES AND WHAT THEY NEED. BUT I WAS CONCERNED ABOUT ADDING ADDITIONAL PERSONNEL.

COMMISSIONER EDWARDS: I AGREE WITH YOU 100 PERCENT. I THINK MY CONCERN WITH THAT DEPARTMENT IS BECAUSE IT IS RIGHT THERE ON THE CAMPUS I WORK ON, AND I SEE HOW THEY WORK SO HARD. I KNOW THEY NEEDED OFFICERS TEN YEARS AGO. AT EACH COMMISSION MEETING, WE TALK ABOUT THE GROWTH, THE GROWTH AND THEY DON'T JUST DEAL WITH DOGS. SO, WE HAVE EMPLOYEES THERE WHO DON'T WANT TO GO ON VACATION BECAUSE THEY DON'T WANT TO LEAVE THEIR WORK ON SOMEBODY ELSE OR THEY DON'T WANT THE STACK OF WORK WHEN THEY COME BACK. SO, THEY'RE NOT TAKING VACATION OR THEY ARE COMING IN SICK. I THINK THAT IT'S MORE THAN ONE DEPARTMENT THAT IS DOING THAT. SO, AS WE CONTINUE TO TALK ABOUT GROWTH OF THE COUNTY, I THINK THAT WE'RE GOING TO HAVE TO EVENTUALLY DEAL WITH SOME OF THE SHORTAGES WE'RE SEEING IN THE DEPARTMENTS. I LOVE THAT WE'RE BUYING EQUIPMENT. I LOVE TO TALK ABOUT GROWTH, BUT AT SOME POINT, WE WILL HAVE TO TALK ABOUT SOME OF THESE DEPARTMENTS AS A STRUGGLE.

CHAIRMAN STRONG: THAT'S GOOD. IF YOU LOOK BACK TO 2013, WE HAD A TOTAL OF 1,094 COUNTY EMPLOYEES, AND THAT INCLUDES FULL-TIME AND PART-TIME. IF YOU LOOK TODAY, WE HAVE 982. SO, WE'RE 112 LESS EMPLOYEES TODAY THAN WE WERE IN 2013. THE BIG THING THAT WE LOOK AT IS THAT WE HAVE DONE A LOT TO INCREASE THE SALARIES, BETTER HEALTH INSURANCE. BUT AGAIN, WITH THE GROWTH OF THIS COUNTY, THERE'S NO DOUBT THAT WE'LL ALWAYS BE LOOKING AT DEPARTMENTS AND THAT GROWTH THAT MAY COME WITH IT.

COMMISSIONER RIDDICK: DO YOU HAVE THE NUMBER OF JOB OPENINGS, PRESENTLY?

CHAIRMAN STRONG: WE HAVE A LOT OF JOB OPENINGS. IT WAS HARD WHAT HAD TO BE DONE HERE. TEN YEARS AGO, I THINK WE, AT ONE POINT, REDUCED OUR WORKFORCE BY ABOUT 250, 260 EMPLOYEES. OF COURSE, WE'RE BACK, GOING IN THE RIGHT DIRECTION AND IT'S A TRIBUTE TO THIS COMMISSION AND EVERYBODY WHO IS A PART OF IT. YOU START TALKING ABOUT THE SIZE OF THIS BUDGET AND \$240 MILLION SOUNDS LIKE A LOT, BUT WHEN YOU START LOOKING AT THE SIZE OF MADISON COUNTY, I THINK YOU ALL ARE DOING A PHENOMENAL JOB STRETCHING EVERY DOLLAR TO GET MORE OUT OF IT. THERE ARE A COUPLE OF OTHER THINGS THAT ARE INCLUDED IN THIS BUDGET. WE HAD \$800,000 PROJECTED LOSS IN PISTOL PERMITS, AND SO, WE'RE TRYING

TO BE SURE THAT WE CAN MANAGE THAT. THE SHERIFF'S DEPARTMENT, THE COURT 1 2 SYSTEM CAME AND REQUESTED \$30,000. THIS WILL BE A COMBINATION OF DRUG COURT, 3 MENTAL HEALTH COURT, VETERANS COURT, DRUG TESTING AND ANKLE MONITORING. 4 YOU START LOOKING AT AN ANKLE MONITOR, IT'S ABOUT SEVEN TO NINE DOLLARS 5 VERSUS ABOUT \$60 A DAY TO INCARCERATE SOMEBODY. OUR JUDGES ARE LOOKING AT 6 EVERY OPTION THEY CAN TO REDUCE THE COST, ESPECIALLY WHEN WE'VE GOT 7 SOMEBODY WHO IS A NON-VIOLENT OFFENDER OR SOMEONE WHO IS NOT A THREAT TO 8 SOCIETY. OF COURSE, I THINK THAT IS A VERY GOOD EXPENDITURE OF THOSE DOLLARS. 9 IT IS JUST ONE OF THESE THINGS, JUST TRYING TO STRETCH IT AS FAR AS WE POSSIBLY 10 CAN. WE'VE GOT INCLUDED IN THIS, THE PROBATE JUDGE, IT'S ABOUT \$750,000 TO REPAIR 11 OR RENOVATE A BUILDING THAT CURRENTLY, WE ARE STORING OUR VOTING MACHINES 12 IN A COUNTY BUILDING THAT IS PROBABLY WORTH A COUPLE MILLION DOLLARS. THIS IS A GREAT EXPENDITURE HERE. IT IS MY HOPE TO GET THAT BUILDING BACK ON THE 13 14 TAX ROLLS, RATHER THAN STORING VOTING MACHINES. I WANT TO THANK FRANK. I 15 DON'T KNOW IF HE'S HERE, BUT I KNOW THAT HE'S WORKING TO GET THAT BUILDING GOING IN THE RIGHT DIRECTION AND HAS BEEN LOOKING AT THAT FOR SOME TIME. YOU 16 17 LOOK AT THE AXION BODY CAMERAS THAT WE'RE TRYING TO REPLACE FOR THE 18 SHERIFF'S DEPARTMENT, WHICH IS CRITICAL, AND THEN, YOU START LOOKING AT THE 19 EFFORT OF THE SHERIFF FOR LESS LETHAL METHOD AND THAT IS TASERS. BODY CAMERAS AND TASERS, THEY WORK TOGETHER. SO, HOPEFULLY THAT WILL MAKE A 20 SAFER MADISON COUNTY. AN ENORMOUS AMOUNT HERE. THE OTHER THING THAT 21 22 WE'RE RUNNING INTO IS THE AVAILABILITY OF TRUCKS AND VEHICLES AND POLICE 23 CARS. YOU'RE SITTING HERE, WE'VE GOT SOME GARBAGE TRUCKS THAT HAVE BEEN 24 ORDERED FOR ALMOST TWO YEARS NOW. WE'RE STILL WAITING ON DELIVERY AND WE 25 INCLUDED THE PURCHASE OF FIVE ADDITIONAL TRUCKS FOR THE SANITATION 26 DEPARTMENT THIS YEAR. WE'RE STILL OUT. COMMISSIONER, I KNOW YOU'RE OVER THAT DEPARTMENT. WE'RE 18 MONTHS, 24 MONTHS IN FROM WHEN WE ORDERED 27 28 SANITATION TRUCKS AND WE STILL HAVE NOT GOTTEN THEM.

32 33 COMMISSIONER HARAWAY: WE ORDERED SOME IN THE PREVIOUS BUDGET CYCLE AND IN THIS CYCLE. THEY'LL BE IN THE NEXT ONE BEFORE WE EVER SEE THEM. A LOT OF THIS EQUIPMENT THAT'S IN THERE, WE MAY NOT SEE IT IN THE NEXT BUDGET. IT MAY HAVE TO BE TRANSFERRED TO '24 BUDGET BEFORE WE SEE IT BECAUSE OF LEAD TIME ON THIS STUFF.

RECOMMENDATION OF TRYING TO BE SURE THAT WE DO EVERYTHING WE CAN WITH THE AMOUNT OF MONEY THAT WE'VE GOT. OPEN FOR ANY FURTHER QUESTIONS. ANY FURTHER QUESTIONS FOR JOSEPH? ANY FURTHER QUESTIONS FOR CAROL, JEFF, ME? THERE IS A MOTION AND A SECOND. ALL IN FAVOR? ANY OPPOSED? THE MOTION CARRIES. THANK YOU, JOSEPH. THANK YOU TO EVERYBODY FOR YOUR HELP. AS WE SAY, WE'LL CONTINUE TO EVALUATE REVENUE AND IF THINGS CHANGE, WE DEFINITELY

OUR 6 EMPLOYEES ARE A VALUABLE ASSET OF OUR COUNTY. WHILE WE HAVE LESS, I STILL 7 BELIEVE IT IS MORE. IT IS BENEFICIAL TO PAY MORE. WE ARE DEFINITELY DOING MORE 8 IN MADISON COUNTY WITH LESS. I THANK EACH OF YOU. THE NEXT ITEM ON THE 9 AGENDA IS ITEM NUMBER 11, APPROVAL OF DEPOSITORY BANK. JEFF? THANK YOU TO 10 EVERYBODY FOR YOUR HELP.
