PROBATE COURT OF MADISON COUNTY, ALABAMA INSTRUCTIONS FOR NAME CHANGE OF A MINOR

REQUIREMENTS:

- A current, non-expired State of Alabama issued Driver's License or State ID for <u>each</u> parent or petitioner. Petitioner(s) must reside in Madison County, and the ID should state a current Madison County address. Physical address is required. PO Box addresses will not be accepted. If the address on identification is not in Madison County, proof of residency will be required (i.e. utility bill, lease, etc.).
- 2. Certified copy of Minor's birth certificate. Birth Certificate must contain full names of parents and will remain with the Court as a permanent part of the file.
- 3. Completed, notarized Petition and Declaration for Minor Name Change
- 4. Filing fee of \$37.00

COMPLETING THE FORMS:

- 1. The Probate Office does not provide legal advice or assist with completing the Petition and Declaration for Minor Name Change.
- 2. The Probate Office does not provide notary services for the Petition and Declaration for Minor Name Change. Please have all documents notarized prior to filing.
- 3. Petition and Declaration for Minor Name Change must be fully completed and legible typewritten is preferred and recommended.
- 4. USE BLACK INK ONLY. Do not mark through or use liquid paper on the Petition and Declaration for Minor Name Change. Petitioner's signatures must be the same as identified on the birth certificate and signed before a notary public. Must use FULL NAMES. Initials or nicknames will not be accepted.
- 5. Both parents are required to sign the petition or sign a consent to the petition. If a parent is unable to sign the petition or consent, see the notes below for additional information.
- 6. If minor is over age 14, they must sign the petition where indicated.
- 7. Completed forms can be filed in person, mailed via USPS or overnight carrier. Please include a check or cashier's check, made payable to the Judge of Probate, in the amount of \$37.00 to:

PLEASE NOTE:

Consent from both parents is required. If a parent is deceased, the Probate Court will require an original death certificate to process the petition. If a parent's rights have been terminated the Probate Court will require a certified copy of the Court's order terminating parental rights. If the requirements set out above cannot be met for the Probate Court to process the petition and enter an order, the Probate Court may set a hearing on a petition for minor's name change. If a hearing is required, it is the responsibility of the petitioning attorney to publish legal notice

in Madison County for three (3) consecutive weeks. Proof of publication must be provided to the Court prior to the hearing.

If a hearing is held, the Minor must attend unless they are over the age of 14 and have signed a consent.
